

Adaptation Futures 2020: Revised Registration Fee, Refund & Cancellation Policy

- Revised Registration Fees: Since the Conference will be held on a virtual platform, the registrations fees have been revised to reflect the change in modality. Please refer to the document titled 'Revised Registration Fee' for the revised rates.
- **Sponsor a participant**: Participants are encouraged to register other colleagues to accommodate the revised registration fees.
 - o In cases where the participant wants to register other colleagues, the participant is required to write to the Adaptation Futures Secretariat at af2020@teri.res.in while marking a copy to mekhala.sastry@teri.res.in and dhriti.pathak@teri.res.in.
 - o In case no colleague is registered, the participant must write to the af2020@teri.res.in and follow the process of refund of the remaining fee. Requests for the same will only be entertained until 15th September, 2021, 11:59 PM IST.
- <u>Transfer of Registration</u>: If a registrant is unable to attend the event for any reason they may transfer their registration, by arrangement with the Secretariat, to someone else for attending in their place.
 <u>Requests for the same will only be entertained until 15th September, 2021, 11:59 PM IST.</u> No transfer requests will be entertained or granted after this date.
- <u>Cancellation</u>: Registrations may also be cancelled provided that the Secretariat receives a written notification any time up until 18 days prior to the conference start date. Kindly note that cancellation requests will not entertained after 15th September 2021, 11:59 PM IST.
- **<u>Refund</u>**: All refund requests must be submitted in writing to <u>af2020@teri.res.in</u>. Refund requests made via any other means will not be entertained.
 - No refund requests will entertained or granted within 15 days of the conference start date.
 In the case of emergency/extenuating circumstances, special requests may be considered on a case-by-case basis by the regional leadership team following the conference.
 - Please note that the participants will have to bear the cost of exchange rate fluctuations as well as other transaction costs incurred by TERI while processing the refunds.
 - In case you are unable to attend the conference but have not informed the organisers of the same up to 15 days prior to the event, no refunds shall be granted.

<u>Please note:</u> Refunds will be made to the same method of payment through which the participation fee was paid.

- o In case the fee was paid via <u>credit card</u>: Please allow one complete billing cycle before refunds appear on your credit card statement.
- In case participation fee was paid via <u>bank transfer or net banking</u>: Along with your email request for a refund, you would be required to attach a *signed letter* requesting the refund. This letter must state the *name of the participant, registration no., name of account holder* and *account number* through which registration fee was paid, along with the *bank's name and address, IFSC/Swift Code* and *BIC No.*; and should be addressed to:
